REPORT OF THE PRESIDENT FOR 2014

Constitutional Changes

With the help of Emeritus Professor Peter Holland and Dr Maria Borovnik we updated and restructured the constitution in 2014 to put some of the material formerly in the constitution, into by-laws. By-laws may be amended at any time by the Executive committee but must be ratified by the next Council or AGM. Constitutional amendments can only be made at the Annual General Meeting.

Constitutional changes which were approved at the 2014 AGM include adding two new objectives ('foster geography and its application in New Zealand society', plus 'support the work of geography teachers'); some new privileges for members, and the ability for members to establish sub-branches or 'clusters' where there are too few members to form a branch. We also clarified the arrangements for branches' holding of the biennial conference. We added transparency to the financial aspects of the society's work by including (in the by-laws) a requirement for the Executive Committee to ratify expenditure and approve anticipated expenditure at our monthly meetings. We also added provision for research and study groups.

Executive Committee

Position Descriptions have been developed with the help of Emeritus Professor Peter Holland and are located in dropbox for the benefit of the successors of those committee members who are no-longer available to be reappointed. We are most grateful for the work of Professor Holland who was co-opted in various capacities since 2011, and most recently to support the governance and management of the executive. Associate Professor Lex Chalmers has also continued, as a co-opted member following stepping down from the position of IGU representative, to provide the Committee with sage advice as well as on-going support to the NZBoGT's Olympiad work and numerous other activities, and we are delighted that he has continued to maintain our connection with Waikato Branch.

A new position of Membership Officer was added to the Executive and we are most grateful to Dr Karen Fisher (Auckland Branch) for taking on this role.

All members of the executive are to be commended for the work they have put into the Society. Secretary, Dr Maria Borovnik, has put in long hours behind the scenes writing up minutes of meetings and ensuring the smooth running of the Society; Treasurer, Dr David Hayward, can take much credit for the improved contract conditions reached with our publisher Wiley Blackwell; Information Officer Dr Matt Henry has made constant updates of the website, Professor Mike Roche has worked tirelessly with IGU and the Geographical Board; Managing Editor Professor Etienne Nel, and in his absence on sabbatical, Dr Nick Lewis, have maintained the high standards of the NZ Geographer; co-opted member Dr Mike Hilton is doing an excellent job preparing for the 2016 Conference at Otago University; Nick Page and Jane Foster and all the other members of the NZ Board of Geography Teachers have as always gone beyond the call of duty to provide strong quality support for secondary-school geography. We also acknowledge the work of long standing Network editor Roger Baldwin who is retiring from this role after many years of service. I congratulate Simon Vale for inspiring his colleagues to take on the role of representing the universities on the postgraduate network. Past-President Professor John Overton and Vice-President Professor Harvey Perkins have provided excellent advice and support as well as leading various submissions on matters dear to the hearts of our members. We also thank our Officer Toa Holani for her work particularly in support of the NZBoGT.

Membership, Branches and Publicity

In an effort to encourage early renewal of membership and payment of subscription fees we obtained agreement at the 2014 AGM to introduce a reduced fee for early/prompt payment of subscription fees (an early-bird discount). With the changes to the publishing contract it is now possible to provide all members with on-line journal access, so a simplification of the entire fee structure is now possible alongside the introduction of an early-bird discount.

As always maintaining current members and attracting new members is an on-going concern. We are particularly dependent on branches for generating exciting activities which publicise the society and emphasise the value of geography. I am very grateful for those branches which have kept me informed of their activities and provided coverage of events for *NZGS News*.

NZGS News was an innovation in 2014 (though not a new initiative as we've had a newsletter in the past) aimed at sharing the decisions and bringing the concerns of the Executive to the attention of members. We managed to produce 8 editions.

Awards

The awards offered in 2014 attracted excellent nominations and the Society was very pleased to congratulate this year's awardees. The Distinguished New Zealand Geographer Award and Medal was presented to Professor Robin Kearns. Council decided to present a special President's awards to the group of postgraduates in recognition of contributions to the establishment of the postgraduate network. Two awards ceremonies were held: one in Auckland as part of the Annual General Meeting held at the old Government House, Auckland University, and the other in Dunedin, hosted by the Otago Branch at Otago University. Both were well attended and delicious refreshments were provided.

REPORT OF THE SECRETARY FOR 2014

The Year

My usual main tasks of: organising Executive, Council, AGM and HoD meetings; liaising between President and Society, with the Executive, with NZBoGT and the Postgraduate Network; keeping branch details up to date and liaising with branch committees; dealing with awards nominations and awardees; and being available for communication between the NZGS and external Societies; have continued. One of the tasks of this report is to summarise main activities and changes during 2014. This year focused on supporting activities related to the IAG/NZGS co-coordinated conference in Melbourne; to complete constitutional changes; and to continue with membership building activities.

Executive

Council decided in 2014 to establish a new Executive Committee position, and Karen Fisher was welcomed to this 'Membership Officer' position by the AGM in Auckland. Karen has proven to be an excellent choice for this position with her energetic and sociable attitude. She has since become quite active in sorting out membership issues and discussing promoting membership within different Society circles.

The Executive welcomed Simon Vale on board the Executive postgraduate representation. Simon has been standing tall and has worked rather hard on keeping the network going, while he has been the only postgraduate representative on the Executive since mid-2014.

The Executive said farewell to Emeritus Professor Peter Holland, and thanked him very much for his invaluable and longstanding contributions to the Society, including chairing the Society as President, and a prolonged Past President position, and then later as Co-opted member to the Executive. Peter has contributed significantly to revisions and updates to the Society's constitution, and he also helped clarifying job positions of committee members. Peter also served the NZBoGT's Maatangi Whenua competitions by marking their assignments. The Society awarded Peter with an Honorary Life Fellowship Award in 2013. Peter has been an exceptionally supportive mentor to me, for which I personally thank him very much.

Another farewell was to Gradon Diprose, who left the postgraduate representative position. Gradon has made significant contributions to the postgraduate network and was substantial in establishing and maintaining the invigorating activities, including the excellent Network's newsletter, virtual seminars, and special conference days, where he was involved in several different panels as presenter and chair. The Executive has acknowledged Gradon's contributions together with those of other postgraduates in a special President's Award for Exceptional Services in 2014. It was great working with Gradon who has left quite a gap.

Video Conference meetings

Once again very many thanks to Melanie Milicich for her trooper attitude within a great deal of technical challenges with maintaining ESocSci based video conference meetings. These have become more reliable towards the end of 2014. Technical support of different universities varies and for some this has become costly.

IAG/NZGS Conference

This year the Waikato Branch took responsibility with hosting the NZGS part of the combined IAG/NZGS conference. As a highlight the branch invited all New Zealand geographers to social drinks, which was a successful event and helped geographers to bond

and network with each other. One of the conference's highlights was the pre-conference postgraduate day. New Zealand postgraduates contributed significantly to this.

Heads of Departments

A meeting between the NZGS Executive committee and Programme Coordinators and Heads of geography departments was held during the afternoon of 1 July 2014 in Melbourne. This meeting served to create awareness and understanding of activities, problems and concerns experienced across the academic geography disciplines. Some of these concerns mentioned were followed up with a Presidential letter to geography departments. Feedback on questions offered for discussion is still underway during the beginning of 2015.

NZBoGT

The Board is continuing to be inspirational in their activities and excellent communications and I am very grateful to Nick Page and Jane Foster for their kind collaboration.

NZGS Awards 2014

The following Geographers received awards in 2014: **The Distinguished New Zealand Geographer Award** (and Medal) was awarded to: Professor Robin Kearns (nominated by Auckland Branch). Three **Distinguished Service Awards** were granted to: Dr David Hayward (nominated by Auckland Branch), Sue Lynch (nominated by Emeritus Professor Peter Holland, University of Otago), and Lennox Sharp (nominated by Professor J.A. Tony Binns, University of Otago). The **Honorary Life Fellowship Award** was awarded to: Richard Heerdegen (nominated by A/Prof Juliana Mansvelt, Manawatu Branch).

The following President's Awards were being granted:

- **Best Master's Thesis** to: Hayley Christine Spark (nominated by Dr Francis Collins, University of Auckland); and to Sam McLachlan (nominated by Professor J.A. Tony Binns, University of Otago).
- **Best Doctoral Thesis** to: Dr Thomas Etherington (nominated by A/Prof George Perry, University of Auckland), and to Dr Amanda Thomas (nominated by Dr Sophie Bond, University of Otago, and Professor John Overton, Victoria University of Wellington).

A very pleasant AGM occasion was held by the Auckland Branch, which was decided in recognition of the highest award and a large number of awards being granted to Auckland geographers.

REPORT OF THE TREASURER FOR 2014

I am pleased to present the annual accounts for 2014. The Society's financial situation is sound but there is a continued erosion of financial reserves owing to consecutive deficits. The decline in membership in recent years appears to have been arrested. However, the challenge remains to increase the income from subscriptions back to former levels.

The first table on page 9 reports the membership of the Society. This reveals a modest increase in both individual and school memberships. This is a reversal of the trend in recent years and was anticipated in my report last year.

Tables containing the financial reports may be found from page 10 onwards with the Statement of Financial Performance and the Statements of Financial Position (Assets and Liabilities), followed by detailed Notes on these. These statements combine the activities of both the Head Office and the NZ Board of Geography Teachers, and their respective bank accounts. This is consistent with the 70th Annual Report and follows a decision made at the 2013 Council meeting. The Society has separate bank accounts for the Head Office and the NZ BoGT, as well as a savings account and new account for the Science Olympiad. The latter is explained below.

The accounts for 2014 show a deficit of \$13,008.63. This may be explained largely through the absence of sponsorship and an increase in some expenditures, most notably the net cost of the contract with Wiley-Blackwell for the publication of the *New Zealand Geographer*, and support for members of the Post-graduate Network for their travel to the biennial conference. The pattern of income and expenditures is similar to previous years but clearly the Society as a whole is spending beyond its means. I anticipate some reductions in expenditures for 2015 owing to the new publishing contract and the absence of one-off expenditures associated with the biennial conference. It is likely that next year's balance will look very different but the modest and limited income base for the Society remains a long-term challenge.

The Statement of Financial Position is perhaps more revealing than in recent years. By the end of the year there had been a significant reduction in the funds held in the Society's bank accounts. In part this accounted for by the operating deficit but in part also by the advance loaned to the Science Olympiad, which is included as an asset in the list of debtors. The Science Olympiad is now an annual event and there is an almost year-round programme of fund-raising and expenditures. As noted in last year's report the Council Executive has resolved to treat this as a separate, self-funding activity; and most importantly, the funds raised for this are not owned by the Society or the NZ BoGT. Further information on the Science Olympiad activities are reported below. However, in 2014 the Society's Executive resolved to use its reserve funds to purchase travel and registration on behalf of the Science Olympiad in advance of the funds being raised. Hence at the end of 2015 but it is expected that a similar amount will need to be loaned again before the end of the year. I anticipate that this will be a regular feature of annual accounts.

Details for the Science Olympiad are recorded on page 15. The Society hosts this activity by providing a bank account to hold the funds raised and making payments. However, the funds generated are not owned by the Society.

Motion of thanks to the Auditor

The accounts have been audited by the Society's Honorary Auditor, Nihal Jayawickrama, and his statement is included. I am grateful for his continued attention to the Society's accounts and will present a motion to the meeting that he be awarded an honorarium in recognition of this service.

Acknowledgements

I would like to express my sincere gratitude to the Society's part-time Administrator, Toa Holani. Toa continues to serve the Society responsibly and at a distance from the Treasurer and several most other officers. Many of the administrative functions of the Society operate by email and Toa is always responsive and attentive.

Owing to my distance from the Head Office I am grateful for the support provided locally by our Trustee, Professor Michael Roche, and Secretary, Dr Maria Borovnik.

Notes to the NZGS Accounts

For the year ended 31 December 2014

The figures given in the Statement of Financial Performance for 2014 combines the activities of both the Head Office and NZBoGT bank accounts. The figures are exclusive of GST. The following Notes relate to the Statements of Financial Performance and of Financial Position for 2014.

- 1 The total income from individual and school subscriptions for 2014 was \$21,129.16. This figure is the total income from subscriptions, and so includes any that will be shared with the NZ BoGT and Branches.
- 2 Royalty income totalling \$213.29 (excluding GST) was received from Copyright Licensing in January 2014.
- 3 Entry fees for the Maatangi whenua competition totalled \$3,069.57 in 2014. The costs of running the competition were \$1,692.00.
- 4 At 31 December 2014 the Society had one Term Deposit. This is nominally shared between the Society at large and the Board of Geography Teachers on a 0.84/0.16 basis. The deposit (including accrued interest) totalled \$88,654.02. The shares between the two accounts at 31 December 2014 (including accrued interest to that date) were:

a) Head Office \$74,469.38

b) NZ BoGT \$14,184.64

Interest earned on the Term Deposit in 2014 totalled \$3,236.96. According to the formula above this would nominally be shared as:

a) Head Office \$2,719.05

b) NZ BoGT \$517.91

- 5 The Society has a RapidSave account with the BNZ. This earns a high rate of interest but requires a regular, monthly deposits. These are made through transfers from the Head Office account.
- 6 Entry fees were collected for the Olympiad trials held in New Zealand. These are considered to be earnings for the BoGT/Society and not included in the separate Science Olympiad account, which is self-funding and independent of the Society's accounts.
- 7 The Society collects a \$2 fee for subscriptions paid by credit card; these amounted to \$56.43 in 2014. The merchant banking fees paid in 2014 totalled \$292.16 and are reported as part of the bank and credit card fees total of \$481.46.
- 8 The rebates to branches paid in 2014 amounted to \$627.40. These rebates are calculated as 15% of the net subscription fee received for each individual member associated with that branch. This excludes schools and overseas members.

9 The contract with Wiley-Blackwell for the publishing of the New Zealand Journal includes a \$14,000 annual fee payable by the Society plus the cost of the Scholar One editorial system, which is offset by a Royalty payment to the Society. These three components are priced in New Zealand dollars, US dollars and Australian dollars, respectively. The balance for 2014 was NZ\$6,091.11. The invoice presented to the Society erroneously presented this amount in Australian dollars and the error was not picked up until late in 2014. The payment made in 2014 was \$6,912.14 including the bank transfer fee, and the overpayment is recorded as an asset in the Statement of Financial Position.

Royalty payments are paid in arrears and so the 2014 payment of \$10,263.23 will be received in early 2015. It is recorded as an Asset in the Statement of Financial Position.

The Scholar One fee is paid in arrears and the fee for 2014 is \$798.74. This is recorded as a Liability in the Statement of Financial Position.

The terms of the contract changed after 31 December 2014. For contract from 1 January 2015 until 31 December 2019 there will be no fees owed to Wiley-Blackwell or for the Scholar One system, and no Royalty payments will be received.

- 10 In 2014 the Society supported members of the Postgraduate Network to attend the jointlyheld, IAG-NZGS conference in Melbourne, in July. Eight awards to subsidise travel costs were made, totalling \$4,200.00
- 11 Travel and meeting expenses for Council Executive members to attend the May Council and September AGM totalled \$2,335.17 in 2014.
- 12 The NZGS is a Constituent Organisation of the Royal Society of New Zealand. The subscription cost for 2014 was \$1,352.00 and was calculated using a formula based upon the number of individual members in the Society.
- 13 The cost for staffing in 2014 was \$11,282.92. This includes wages for the part-time Administrator and PAYE payments.
- 14 The Society awards an honorarium to its Honorary Auditor. The amount was reduced in 2014 by mutual agreement.
- 15 Awards were made to one school and 17 school students as prizes for the 2014 Schools' Geography Competition. The funds for this were donated by Dr Ann Pomery and CSAFE (Otago University) in 2013, and have been carried over to fund prizes in subsequent years.

Two awards totalling \$125 were not banked in 2014 and so are included as Liabilities. The balance of the donated funds is \$775 and this is recorded as a liability in the Statement of Financial Position.

16 A prize of \$500 was awarded to Sarah Cantlon of Hamilton Girls High School for the BoGT's Excellence in Geography Teaching and Learning Award in November 2014.

- 17 Travel and meeting expenses for the NZ BoGT's AGM totalled \$3,944.36 in 2014.
- 18 The honorarium paid to the editor of the BOGT's 'Network' newsletter in 2014 was \$2,000.
- 19 The BoGT incurs costs supporting the trials to select the Science Olympiad team each year. These are considered to be the BoGT/Society's financial support for the Science Olympiad. The participation in the annual Science Olympiad competition is considered to be separate and self-funding activity. Funds are raised independently of the Society primarily through participants' (students') contributions and grants from the Royal Society of New Zealand. In 2014 these funds were held in the BoGT bank account but in December a separate bank account was opened in order to keep these funds separate.

In 2014 the Society provided further financial support to the Science Olympiad team through using its reserve funds to make payments for the registration fee and international travel bookings. These needed to be made in advance of receiving the students' contributions and the Royal Society grants. In effect, these were loans that were reimbursed by the middle of the year. The 2014 competition was a self-funding activity. Other than for the following exception - and that explained in note 22 below - the only financial cost to the Society is the loss of interest earnings.

A duplicate payment of \$114 was made in error to Orbit Travel on 1 April for travel costs for the 2014 Science Olympiad. The error was discovered in late 2014 and it is proving difficult to obtain a refund. This is recorded as an Asset in the Statement of Financial Position.

- 20 The Society incurred a deficit of \$13,008.63 in 2014.
- 21 The BNZ Achiever Savings account was closed in 2014. It had not been used for quite some time.
- 22 Payments of the registration fee and air fares for the 2015 Science Olympiad competition were needed before the end of 2014 - the latter in order to take advantage of favourable travel bookings. As before the Society used its reserve funds to support the competition through paying for these costs in advance. These payments were made in December 2014 and are recorded as Assets in the Statement of Financial Position. They are not recorded as Expenditures by the Society since they will be reimbursed in 2015 when students' contributions and RSNZ grants are received.
- 23 Subscriptions received since 1 October 2014 are considered to be for the 2015 year and so are reported as a Liability.

SCIENCE OLYMPIAD

The Science Olympiad is an annual competition held in conjunction with the IGU conferences. The New Zelaand teams are coordinated by the NZ BoGT but the activity is separate and self-funding. This statement is included in the Society's Annual Report because the funds are held in a Society bank account on behalf of the Science Olympiad participants and organisers. The funds do not belong to the Society.
