## **REPORT OF THE PRESIDENT FOR 2017**

#### Conference

During 2017, organisation of the biennial conference of the Society to be held jointly with the Institute of Australian Geographers in 2018 began in earnest. The conference will be hosted by the School of Environment at the University of Auckland and focused on the theme: 'Creative Conversations, Constructive Connections'. The dates for the conference are 11-14 July 2018.

#### New Zealand Geographer

The journal continued to be an important element of the Society's activities. The year began with the *New Zealand Geographer* safe in the hands of Managing Editor and Chair of the Editorial Board Professor Etienne Nel and the established editorial team. After the Annual General Meeting in October Professor Nel stepped down at which time Associate Professor Juliana Mansvelt took up the role of Managing Editor, and Associate Professor Nicholas Lewis assumed the Chair of the Editorial Board. In addition, Dr Francis Collins took up the role of Human Geography Editor, and Associate Professor Nicolas Cullen become Physical Geography Editor.

#### **Research and Study Groups**

The Society currently has three Research and Study Groups.

In 2017 the *Mobilities in Geography Research and Study Group* produced a Special Issue of the *New Zealand Geographer* (Mobilities and Transformation, Volume 73 (2), 2017) that show cased the range of NZ geography research in this area. Members also contributed to the 7<sup>th</sup> Mobilities Symposium, held at Massey University's Albany campus. The network has liaised closely with the eSocSci Mobilities in Aoteaora New Zealand network.

After a successful themed section in the *New Zealand Geographer* (Volume 72 (3), 2016), in 2017 the *Women and Gender Geographies Research and Study Group* held regular workshops and video conference meetings, and an annual symposium in February 2017 in Auckland. The Group is also closely linked with its eSocSci equivalent *Women and Gender Geographies Research Network*.

The *Rural Geographies Research and Study Group* is in the early stages of development and had its first meeting in February 2017.

#### **Annual General Meeting and Awards**

The 2017 Annual General Meeting and awards ceremony was hosted by the Otago Branch of the Society at the University of Otago. Thanks to the Branch Executive (supported by Secretary, Dr Maria Borovnik) for organising such a successful event.

#### Membership

Membership Officer (Dr Karen Fisher), supported by Treasurer (Dr David Hayward), Administrator (Toa Holani) and Information Officer (Dr Matthew Henry), continued to improve our membership records and systems throughout the year. This proved a challenging task but significant improvements were made. Despite this, membership of the Society remains a concern with numbers being less than ideal.

#### Publicity

Information Officer, Dr Matthew Henry, responding to perceived problems with the Society's website oversaw its updating in the early part of 2017. This work included the development of a membership module on the website aimed at allowing members to pay their subscriptions by credit card and allowing the Membership Officer and Treasurer to have improved access to data on membership. The Information Officer, with the help of the Secretary, also took over responsibility for the production of the Executive Newsletters.

#### International and Statutory Agency Links

Professor Michael Roche continued to represent the Society in the work of the International Geographical Union (IGU). This work, along with New Zealand participation in the IGU International Geography Olympiad, a competition for 16- to 19-year old geography students from all over the world, is supported financially by the Royal Society of New Zealand (RSNZ).

Professor Roche also continued the Society's representation on the New Zealand Geographic Board.

In 2017 the Royal Society of New Zealand continued to hold meetings of its constituent member organisations at which Vice President Professor Lynda Johnston represented the Society. These meetings give the Society's Executive members the opportunity to contribute to the deliberations of the Royal Society and to understand better the challenges being faced by other New Zealand scholarly organisations.

#### Early Career Researcher Network (ECRN)

During 2017 the ECRN replaced the Postgraduate Network thus extending its role in the support of both postgraduate researchers and new and emerging post-PhD researchers. The Network's activities included: webinars, social events, and PhD gatherings. Plans were developed for a strong presence at the 2018 NZGS/IAG conference in Auckland. ECRN has a NZGS branch presence and was represented on the Executive early in the year by Tegan Baker and Andrew Neverman and later by Swati Shah and Roseanna Spiers.

#### New Zealand Board of Geography Teachers (NZBoGT)

The NZBoGT is a subcommittee of the Society. Its vision is to support the quality teaching and learning of geography in New Zealand secondary schools; raise the profile of geography for students through participation in NZBoGT competitions and events; and promote links between the secondary and tertiary sectors and wider within the geography community. The Board advises and consults with the Ministry of Education and New Zealand Qualifications Authority on matters of interest to New Zealand geography teachers and students. It also supports activities and professional development programmes for teachers and students at the local level through either Subject Associations or NZGS branches.

The NZBoGT continued to make a vitally important contribution to the Society and during 2017 was well represented on the Executive by Jane Foster, the Board's secretary, Dr Mike Taylor its pre-service

teacher education representative, and the Society's Tertiary Liaison to the NZBoGT, Professor Tony Binns.

Sue Lynch, who was the Chair of the NZBoGT during 2016, stepped down early from her role at the beginning of 2017, and Louise Richards, formerly Deputy Chair took over the role. The secondary school geography competitions continued to be important 2017. The Board also worked on updating a school membership list.

#### Executive

A number of Executive members were either confirmed in continuing roles or appointed as new members in 2017:

Dr Maria Borovnik was appointed as Secretary for a further term.

Co-opted Member Gail Adams-Hutcheson was appointed for one more year in her capacity of ECRN support.

Professor Warwick Murray, Victoria University of Wellington, was confirmed as incoming Vice President, to take up his role at the beginning of 2018.

Dr Ralf Ohlemüller, University of Otago, was confirmed as Society Treasurer.

All other members were confirmed as continuing.

All members of the Executive provided exceptional service and I am very grateful for the very significant contributions that they made during 2017. Special thanks go to Secretary Dr Maria Borovnik, Treasurer Dr David Hayward for the extra miles they had to travel during the year in support of the Society. A special mention also for Vice President Lynda Johnston and Immediate Past-President Ann Pomeroy for the help and support they gave me during my last year as President.

#### Executive

At the end of 2017, and after six years of engaged service, including regular productions of newsletters, Past President Dr Ann Pomeroy stepped down from the Executive committee. My sincere thanks to Ann for her excellent work, good humour and kind team spirit.

National Treasurer, David Hayward, also stepped down from his role at the end of 2017, after more than ten years of contributions to the Executive. ## **REPORT OF THE MEMBERSHIP OFFICER FOR 2017**

#### **General comments**

In 2017, we moved to an online process for managing the membership. Emails were sent via the NZGS community email list and other local lists from late 2016 encouraging members to subscribe to the NZGS online. We did not carry any membership forward although profiles were created for the Life Fellows. Rates remained the same as in in 2016 (see Table 1), with early bird extended to 1 May. Initially, there was a slow take-up from schools so David Hayward and Toa Holani organised for invoices to be sent to schools. This raised the number of schools subscribing, but numbers for 2017 were lower than in previous years.

- There are a number of benefits associated with moving to a web-based membership database. Where subscribers pay using PayPal or credit/debit card, payment is immediate and subscription status is automatically 'Active'. However, where subscribers generate an invoice to pay offline and status is 'Pending', financial records need to reconciled with subscription information and status is manually updated to 'Active' when payments are received. This job was performed mostly by Toa.
- A single database that is accessible to both Toa and I is an improvement on the problem we experienced in 2016 when we were working off 2 separate Excel spreadsheets.
- The database has been set up to automatically generate emails for subscriptions and/or payment. These are sent to the <u>membership@nzgs.co.nz</u> and to the email address provided for the profile. However, some subscribers have said they did not receive confirmation.
- Reminder emails are set to be sent 10 days before subscription ends; 5 days before; and, 5 days after. There were some technical problems with subscription periods. When schools join, the subscription end date generated is 365 days after signing up. I manually updated these to end in late January/early February 2018 to coincide with when schools come back.

There were some early teething problems with the website so I fielded a number of inquiries regarding how to join, how to pay, what the emails meant, and so forth.

#### Subscriptions 2017

Subscriptions in 2017 were 203 (96 individuals and 103 schools). Table 2 provides a breakdown by membership category and branch. Membership in 2017 was significantly lower than in previous years (see Table 3).

Total assets of the Society at 31 Dec 2017 were \$150,027.15 down from \$153,656.18 on 31 Dec 2016. After a modest surplus in 2016 of \$368.82, there was a considerable deficit of \$8,931.55 in 2017.

The 2017 accounts are currently in the process of being reviewed by Audit Professionals, Dunedin, NZ. The auditor's report will be presented to the NZGS Executive at its November or December 2018 meeting.

Notes to the NZGS Accounts for the year ended 31 December 2017

The figures given in the Statement of Financial Performance for 2017 combines the activities of both the Head Office and NZBoGT bank accounts. The figures are exclusive of GST. The following Notes relate to the Statements of Financial Performance and of Financial Position for 2017.

Notes

- Royalties were received from Copyright Licensing Limited. This payment covered a backlog of royalties over preceding years and so was greater than expected. There were no royalties from Wiley- Blackwell since these are not provided for by the current contract for the publication of the New Zealand Geographer.
- 2 The Maatangi Whenua competition involves secondary school students throughout the country who compete in several regional competitions.
- 3 The NZ BoGT organises competitions to select team members for the annual, international Science Olympiad.
- 4 The Society has one term investment that matured on 19 October 2017. It was reinvested for 12 months.
- 5 The Society has a Rapid Saver account with BNZ. This pays a rate of interest slightly below that of term investments but requires a minimum monthly deposit. One hundred dollars is transferred each month from the Head Office account to ensure that the bonus interest rate is earned. In 2017, these monthly payments only commenced in May, hence the lower annual interest compared to 2016. The Rapid Saver account has provided flexibility when the need arises to draw upon funds such as, for cash flow purposes or the annual advance we provide to the Science Olympiad team for their purchase of air travel and accommodation in ahead of fundraising. The latter is re- paid to the Society.
- 6 Rebates to Branches are calculated at 15% of the ex-GST subscriptions of individual members who reside in the relevant region.
- 7 The expenses for meetings included the travel and venue expenses for the Council meeting and the travel expenses for Officers to attend the Annual General Meeting.
- 8 The NZGS is a Constituent Organisation of the Royal Society of New Zealand. The subscription is calculated as \$4 for each of the Society's number of individual, financial members, plus GST.
- 9 The Society employs one part- time administrator, and wages totalled \$12,436.45 in 2016. The apparent increase over 2015 is due to the timing of payments across the two periods and an increase in the administrator's wage approved by the Executive in September 2016.
- 10 The Society purchases Associations liability insurance. The premiums for 2017 were paid in 2018 and will show therefore show up in the 2018 accounts.
- 11 The Society stopped its credit card with WestPac in Feb 2017. The Society holds a Paypal account for which an annual fees is to be paid. This fee still needs to be added to the 2017 accounts but the treasurer was unable to do this at the time of writing of this report.
- 12 The Society is obliged to file its Annual Report with Charities Services and there is a filing fee for this.
- 13 The Society awards an honorarium to its Honorary Auditor at its AGM in September.
- 14 The NZ Board of Geography Teachers awards an honorarium of \$500 per issue to the editor of its Network magazine.
- 15 The NZ Board of Geography Teachers held its Annual General Meeting in April and the expenses are for the Board members' travel and the venue expenses.
- 16 The BNZ NZBoGT Olympiad account was set up to manage the financial transactions associated with the Geography Olympiad. It was not listed as a separate entity in the 2016 Financial Position Statement.
